MEETING MINUTES September 13, 2023

I. Attendance/Call to Order

II. Public Hearings

a. 5600 Broadway - Cassie & Vincent Marino - New eave on accessory structure revision

Mrs. Marino was present at the meeting. She explained that the new drawings show that the proposed eave is going to increase in size from what was originally proposed. The HPC discussed the changes and the addition. There was no opposition to the changes.

MOTION APPROVED: In a vote of seven (7) ayes to zero (0) nays.

Justification: The new work follows the Secretary of the Interior's Standards for Rehabilitation, Number 9 – The new work is compatible with the massing, size, scale and architectural features to protect the historic integrity of the property and its environment.

b. 11 West Main Street (Precious Cargo Plant Shop) – Wesley Mesanovic – New sign

Mr. Mesanovic was present at the meeting. He explained the proposal for a new white-enameled aluminum sign attached to the front of the roof at his business. M. Meyer clarified that the proposal does not include lighting. There was no other discussion.

Justification: The new work follows the Secretary of the Interior's Standards for Rehabilitation, Number 9 – The new work is compatible with the massing, size, scale and architectural features to protect the historic integrity of the property and its environment and #10 – New additions and adjacent or related new construction shall be undertaken in such a manner that if removed in the future, the essential form

Mr. Severyn was present at the meeting. He explained plans to replace the existing signage with new signage at the property. The new signage design that was preferred by the HPC was Option 1. There will also be 3 gooseneck lights added to illuminate the signage. There was no other discussion.

The design of the sign also falls within the HPC's Signage Guidelines.
